Edelweiss Financial Services announces INR 4,000 million Public Issue of Secured Redeemable Non-Convertible Debentures (NCDs)

- ➤ Effective Yield of up to 10.46 % per annum*

Mumbai, April 5, 2023: Edelweiss Financial Services Limited ("EFSL"), announced the public issue of Secured Redeemable Non-Convertible Debentures ("NCDs") of the face value of ₹1,000 each, amounting to ₹ 2,000 million ("Base Issue"), with an option to retain over-subscription up to ₹ 2,000 million aggregating to ₹ 4,000 million.

There are 10 series of NCDs carrying fixed coupons and having tenure of 24 months, 36 months, 60 months and 120 months with annual, monthly and cumulative interest options. Effective annual yield for NCDs ranges from 8.94% p.a. to 10.46% p.a.

The Tranche II Issue is scheduled to open on April 6, 2023 and close on April 21, 2023 **

At least 75% of the funds raised through this Issue will be used for the purpose of repayment /prepayment of interest and principal of existing borrowings of the Company and the balance is proposed to be utilized for general corporate purposes, subject to such utilization not exceeding 25% of the amount raised in the Issue, in compliance with the Securities and Exchange Board of India (Issue And Listing Of Non-Convertible Securities) Regulations, 2021, as amended from time to time ("SEBI NCS Regulations").
